Black Parenting Under the White Gaze

Submission deadline: April 13, 2020 at 11:59PM

Conference Date: Saturday, October 24th, 2020 Toronto

This gathering will focus on the complexities of parenting within the African, Caribbean, and Black (ACB) communities in Canada. Black parents are not a monolithic group and this is reflected in the various parenting practices and strategies that exist. However, regardless of their identities, social locations, and parenting practices all Black parents experience anti-Black racism when interacting with education, recreational, child welfare, policing, transportation, and social services and systems. Researchers, governments, human rights commissions, academics, community agencies, as well as news reporters confirm what Black parents have been saying about their experiences – that anti-Black racism is prevalent in Canadian society and by extension creates unique challenges for Black parents.

The existing research indicates that Black Canadian parents experience institutional racism in all segments of society including, within their children's school system, living in low and substandard housing, being over-policed through carding/street checks, experiencing high underemployment and unemployment rates, a lack of access to adequate health care, and many other areas (Adjei, Mullings, Baffoe, Quaicoe, Abdul-Rahman, Shears & Fitzgerald, 2017; African Canadian Legal Clinic, 2012; James & Turner, 2017; Lalonde, Jones, & Stroink, 2008). This gathering will explore the experiences of Black parents and caregivers as well as the many ways in which they have and continue to resist and challenge anti-Black racism.

The work of the planning committee is grounded in Dei's (1996) conceptualization, which builds on Crenshaw's (1989) notion of intersectionality within a critical race theory (CRT) framework. Dei (1996) expanded on Crenshaw's work of race, gender and class to include sexuality and developed a critical integrative framework that examines the intersections of race, gender, class, sexuality and social oppression. Critical race theorists adopt a position known as 'racial realism' which holds that racism is a means by which societies allocate privilege and status (Delgado and Stefancic, 2017). This gathering takes a race-conscious approach to understanding how laws and policies marginalize Black parents and impact how they choose to parent. This conference will contribute to the scholarship in many ways by providing models of effective intervention strategies, support programs and services for Black parents. As well, it will help highlight the complexities of Black parenting and the resilience of Black parents. This conference will serve as a means to help validate and empower Black parents while educating those who work with Black parents.

Audience:

This conference is for Black parents and those caring for Black children, Black community members, professionals working with Black communities (e.g. social workers, educators, health care professionals), researchers, policy makers, students and anyone interested in learning more about Black parenting in Canada.
